Issue Three– Healthcare Freedom Amendment Vote YES

By voting yes on Issue 3, Ohioans will preserve their freedom to choose healthcare coverage free of abortion funding and healthcare rationing.

With the adoption of Ohio's Health Care Freedom Constitutional Amendment, a firewall will be erected legally to protect Ohioans against the unconstitutional mandates of the Nationalized Healthcare Act of the 111th Congress.

- Government should not have the power to force you and your family to buy a specific type of health insurance or health care from another.
- The freedom to not be forced to purchase government-defined private health insurance is a fundamental right, implicit in the concept of ordered liberty and deeply rooted in our history and tradition.
- You and your family should never be imprisoned, fined or prosecuted for choosing health insurance or treatment different from government requirements.

Issue 2

Referendum

REFERENDUM ON NEW LAW RELATIVE TO GOVERNMENT UNION CONTRACTS AND OTHER GOVERNMENT EMPLOYMENT CONTRACTS AND POLICIES

A majority yes vote is necessary for Amended Substitute Senate Bill No. 5 to be approved.

Amended Substitute Senate Bill No. 5 is a new law relative to government union contracts and other government employment contracts and policies.

A "YES" vote means you approve the law.

A "NO" vote means you reject the law.

Issue 1

Proposed Constitutional Amendment

TO INCREASE THE MAXIMUM AGE AT WHICH A PERSON MAY BE ELECTED OR APPOINTED JUDGE, TO ELIMINATE THE AUTHORITY OF THE GENERAL ASSEMBLY TO ESTABLISH COURTS OF CONCILIATION, AND TO ELIMINATE THE AUTHORITY OF THE GOVERNOR TO APPOINT A SUPREME COURT COMMISSION. Proposed by Joint Resolution of the General Assembly To amend Section 6 of Article IV and to repeal Sections 19 and 22 of Article IV of the Constitution of the State of Ohio

A "YES" vote means approval of the amendment.

A "NO" vote means disapproval of the amendment.

OCA LEGISLATIVE INITIATIVES

Founding of America Documents Bill-S.B. 165. Requires the instruction of The Declaration of Independence, The U.S. Constitution with emphasis on The Bill of Rights, The Ohio Constitution, The Northwest Ordinance, and the Federalist Papers in Ohio high school history curriculum.

D-Day Landing Prayer Project-H.R. 2070. Would place FDR's D-Day Landing Prayer at The WWII Memorial in Washington, D.C. The bill currently has 40 co-sponsors in Congress.
